The **Governor General spent \$117,000 on professional dry-cleaning** (see archived version [here](#)) services since 2018 alone - report by Alex Dhaliwal, October 4, 2023.

According to the Canadian Taxpayers Federation (CTF), Rideau Hall spent more than \$1,800 a month on dry-cleaning services since 2018 — equivalent to dry cleaning 13,831 blouses during that period.

How much do you spend on cleaning your clothes?

Well, taxpayers pay \$38,000 on the Governor-General's clothes every 16 months and that's on top of making over \$340,000/year in salary. Justin Trudeau is High Maintenance

Have you any idea how much Trudeau's marital issues cost taxpayers? Buckle your seat belts for this shock ...

According to insiders, his mansion at Harrington Lake was built in response to Trudeau's marital trouble Canada's National Capital Commission (NCC); the federal agency that manages national heritage properties including the Prime Minister's homes, was directed to construct a sprawling **second mansion at Harrington Lake** by the Prime Minister's Office (PMO) in late 2019 — shortly after the federal election in October and just days following turbulence in the marriage of Justin Trudeau and Sophie Gregoire, a source inside the PMO tells The Chronicle.

The \$8.6 million in federal spending was not publicly disclosed until April of this year, which included \$3 million to renovate the main house, \$2.5 million to reconstruct and relocate what has been described as a caretaker's house on the grounds, and \$3.6 million to construct a second mansion that is intended for the Trudeau's' use.

Just days after Gregoire threatened to divorce Trudeau October 2023, when she first began refusing to sleep under the same roof with him, the PMO ordered the NCC to proceed with millions of dollars in unplanned projects at the Prime Ministerial retreat.

"Spending millions of dollars to accommodate the evolving nature of the Prime Minister's marriage is not fair to the Canadian taxpayer," a disgruntled political staffer explained.

Indigenous Services Minister, at the time Marc Miller, and the Immigration Minister in 2024, said recently in the book, *Promise and Peril* (2019), that

"Trudeau goes to Harrington Lake to get away and chill and not be judged when he's chilling."

Harrington Lake is a 5.4-hectare property which includes four buildings: the main house, the staff cottage, the upper guest cottage and the lower guest cottage. In addition, another 'main house' was constructed earlier in 2023.

A source familiar with the property believes Sophie Trudeau and her children are not living in the traditional main house, based on photos that she has posted on Instagram.

Trudeau and Gregoire have experienced marital troubles since last October 2022, and after a few short months of counseling, the couple separated in February 2023. Gregoire has been living at Harrington Lake with their three children.

No money for veterans said Trudeau, but after Prime Minister Justin Trudeau and his estranged wife officially separated, their family enjoyed [a round trip to Tofino](#) - in mid-August 2023 — costing taxpayers a whopping \$74,178 to charter a Royal Canadian Air Force jet.

As a Crown corporation, the NCC is subject to the *Access to Information Act*, the *Privacy Act* and the *Public Servants Disclosure Protection Act*, as well as Government of Canada directives on proactive disclosure — though the Trudeau government has not been complying with the spirit of those rules. So much for the claim that the government aimed to strengthen public sector management by enhancing transparency and oversight of public resources.

The NCC argued that \$83 million in renovation projects is necessary to bring 24 Sussex to 'Good' condition (without 'modernizing it') and is now necessary to address fire hazards at the 34-room official residence. The Trudeaus have refused to reside in the Prime Minister's official residence since taking office in 2015, despite former Prime Minister Stephen Harper using the property with no complaints.

It is really hard to justify \$18 million spent on a security system for the official residence when he is not occupying the residence. Instead, the Trudeaus chose to move into the recently renovated Rideau Cottage, on the grounds of the Governor General's palace (known modestly as Rideau

Hall). If you think that waste of money was impossible to justify, wait until you learn about the barn.

At the time, critics said that **Trudeau's complaints about the adequacy of 24 Sussex were contrived and disrespectful to taxpayers.**No kidding!

Beyond the one-time spending request, the NCC is also asking for an increase in annual appropriations of \$24.6 million for ongoing maintenance, repairs, and renovation projects.

The NCC already spends \$5 million annually on capital projects — repairs to the official residences and other projects in the Ottawa-Gatineau region.

More than \$5 million has already been spent in 2015 and 2017 for security upgrades at Rideau Cottage, in order to accommodate Trudeau's displeasure with the official residence at 24 Sussex (also known as Rideau Hall).

Did you know that the [National Capital Commission built a 2-storey barn](#) (if that link doesn't work, see [here](#)) at Rideau Hall for storage of who-knows-what, and it cost YOU the taxpayer, over \$8 million, plus ongoing private security detail?

Listen to this [testimony about this bizarre barn](#), (archived [here](#)) including that it's **1-storey, has an elevator** which the witness didn't know whether it goes up or down, or even why the barn has fibre optics. It may have the heftiest security of any government building. The witnesses could not answer a single question!

We are certain there are thousands of builders out there who could build a BARN for storage, for well under \$100,000. We'll leave you to imagine what the other \$7,900,000 was for.

At the very least, that amount could have housed 160,000 homeless Canadians for at least one full year, at \$40,000 per homeless Canadian.

Details of the project emerged from access-to-information records obtained by the Canadian Taxpayers Federation. All totaled, the Barn cost taxpayers \$8,049,853. Why, because it's carbon neutral and tied to the UN's climate change narrative.

The [transcript](#) uncovered the **sole-source contracting for the development of the ArriveCan app by GCStrategies!** What is learned, is that **millions of dollars go to contractors for work that was never done, or never necessary and accounted for.** Public Services and Procurement Canada is asleep at the wheel or is complicit.

"This [GCStrategies] is a two-person consulting firm that doesn't produce a product, that doesn't operate out of a bricks-and-mortar

entity, that largely works out of a basement, and that has, over the course of a number of years but in relation to ArriveCAN, hit the taxpayer lottery of \$9 million for doing nothing other than finding professionals to do the work. It's a pretty good gig. I bet there are millions of Canadians who would love that opportunity.” ~ Larry Brock, Committee member

Considering the fact that government contractors are handling sensitive public private data, they need sign no non-disclosure agreements and are rarely vetted.

“Going back to the standard practices, we've heard about standard practices, and I find them outrageous when it comes to the procurement here. PSPC admitted that there's literally no limit on what the commission's contractors can pocket on government contracts. If we have a project like Botler's software, where the contractor takes 15% or 20% and the subcontractor takes another 15% to 30%, then the people doing the work get what's left. Let's say \$100,000 of federal government money is spent on a project like that. It could end up being only \$56,000 that goes to the project work.

The government could get the exact same thing for half as much based on that. There are contracts with even more layers and deeper commissions than that, as you know. The government is admitting that it doesn't know how deep these commissions go.

The Treasury Board Secretariat is mandated to make policy recommendations to protect tax dollars. As a CTO, you do everything you can to stop this runaway gravy train by imposing a limit on commissions. Why hasn't the government hired its own IT recruiters? By the numbers we're seeing, you could hire 10 IT recruiters at the Governor General's salary, based on what GC Strategies got, and still save millions of dollars a year.” ~ Gordon Johns, Standing Committee member.

[La Presse](#) reported that GC Strategies has won approximately 140 federal government contracts totalling \$258 million since 2015. The Department of Public Services and Procurement (a private corporation) announced that all these contracts will be subject (PSPC) to review. Dah!!! The very ones who have either allowed this travesty or been complicit in it get to investigate themselves.

The cost to every man, woman and child to keep this criminal gang 'protecting' us, is roughly \$33,000/day, and that does not include the pensions for life they get.

And Then There Are Parasites Called Senators ...

A Senate committee on December 14th, 2023 [gave themselves a 38% increase in living expenses](#) for legislators who stay in Ottawa hotels while on business. "Senators actually are struggling," said one \$169,600-a year appointee: "It is a pretty serious situation."

Grants and Awards to Pride, Foreign and Other Parasites

The federal government has ordered Toronto Pride to repay \$505,000 in grant money after a KPMG study, conducted in 2021, confirmed that many of the pervert projects for which it received [\\$1.8-million in taxpayer](#)

funding were not completed. It will never happen as the organization has gone bankrupt.

According to the Canadian Taxpayer Federation, **between 2012 (Conservative Party days) to 2022 (Trudeau Liberal days), the federal government spent a half-million dollars to host the Public Service Award of Excellence; \$80,000 of that money went to buying very fancy trophies.**

The gaudy galas bestowed federal bureaucrats with expensive awards even though departments consistently failed to hit even half of their performance targets.

According to government records, Prime Minister Justin Trudeau and his cabinet wined and dined in Charlottetown, P.E.I. last summer (2023). On December 11, 2023, Toshifumi Tada, president and CEO of Medicago, testified to the House of Commons health committee amid a parliamentary inquiry into their \$323 million vaccine contract that they delivered NO doses. Of that amount, \$40 million will be returned to government coffers, but hasn't. The rest goes into political pockets. See the story [here](#).

The news came after Conservative, Bloc and NDP MPs on the House of Commons Health Committee grilled the Public Works Department over the seven vaccine deals they made during the pandemic.

In October 2020, the Trudeau Liberals signed a "non-refundable" advance purchase agreement with Medicago despite no reassurances that Health Canada would approve the vaccine for consumption.

Including Medicago, the feds signed agreements with Moderna (up to 44 million doses), Pfizer-BioNTech (up to 51 million), Johnson and Johnson (up to 38 million), Novovax (up to 76 million), Sanofi-GlaxoSmithKline (up to 72 million), and AstraZeneca (20 million) at a cost of \$8 billion.

Health Minister Mark Holland justified the \$150 million advance purchase agreement, claiming Canadians needed a quick vaccine supply. The real reason was that Trudeau was getting a 40% commission/kick-back for every doze injected. See [here](#) about Trudeau getting rich injecting Canadians- 40% commission.

Tada told MPs his company used the money to manufacture the "at risk" vaccine, purchasing raw materials and hiring some 400 staff to oversee their operations in Québec City.

Industry Canada also provided the company \$173 million to build a factory, but Medicago ceased their operations in February 2023.

The federal government and Medicago agreed to terminate the \$323 million contract in June 2023 by mutual consent — with the former (being the taxpayer) unlikely to see funds returned from the advanced purchase agreement.

The taxpayer-funded research and development assets, including intellectual property and equipment will be transferred from Mitsubishi to Aramis, reported the CBC.

This transfer of course, is a public-private partnership that then will transform into a private enterprise.

The claim that thousands of children went 'missing' from Indian residential schools is disproved by the thousands of quarterly returns regularly compiled by the schools and sent to the Department of Indian

According to the historical medical records, [here](#), Dr. Peter Bryce, Medical Inspector for the Department of the Interior and the Department of Indian Affairs, wrote in the DIA Annual Report for 1906 that the indigenous population of Canada was declining, despite a high birth rate. He ascribed the decline to disease, estimating that

"the Indian population of Canada has a mortality rate of more than double that of the whole population, and in some provinces more than three times", and that "the one dominating cause of the excessive mortality everywhere is this lack of sanitary knowledge or of how to live in houses, and that the death-rate is due to the same cause, tuberculosis".

private corporate 'partner' called Shared Services Canada that was just too busy pushing the UN's 'diversity' scheme to notice the waste.

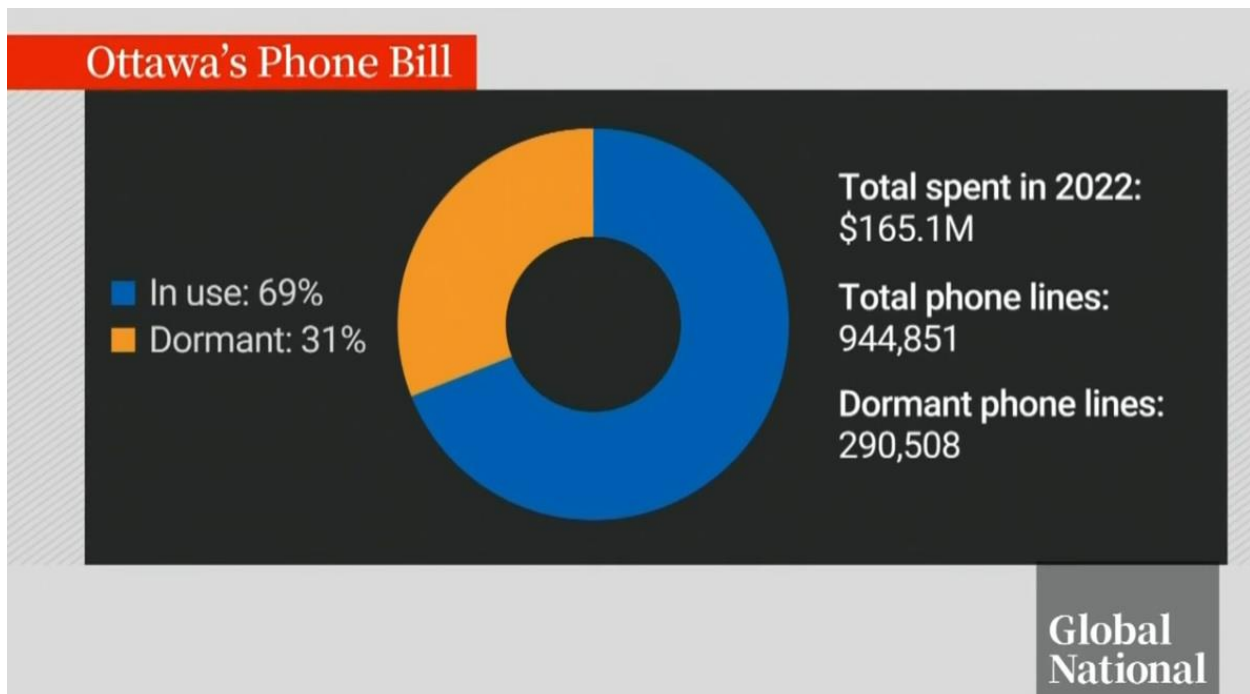

Did you know that unused government-issued cell phones cost taxpayers millions during pandemic? If not see [here](#). And that more phones were issued then there were employees, although this is understandable since many moonlight and have private businesses.

Blacklock's Reporter says the investigation revealed a significant increase in dormant telephone accounts, reflecting the impact of work-from-home orders.

"The number of mobile devices that had not been used for three or more months increased by 65% between March 2020 and March 2023," stated the report.

At the same time, the service plan fees for these unused phones cost hundreds of thousands of dollars per month, totaling \$5.9 million in 2021 and \$3 million in 2022. The average monthly cost of unused phone service plans was \$253,832."

Auditors identified 91,237 mobile phones issued to employees that went unused, possibly due to the increased use of videoconferencing tools such as Microsoft Teams during remote work.

"During the pandemic, mobile phones were provisioned for public servants to enable them to contact their teams and provide services to Canadians while working from home," the auditors noted.

"Since then, the adoption of Microsoft Teams has decreased many public servants' reliance on mobile phones."

The audit also highlighted an overabundance of government-issued cellphones and landlines, surpassing the number of federal employees. Auditors reported more than 840,000 phone lines for 375,000 employees, with annual telephone line costs reaching \$339.6 million — a 73% increase since 2019."

In response to the COVID-19 pandemic in 2020, Prime Minister Justin Trudeau mandated that most federal employees vacate government buildings for health reasons.

Likewise, Medicago, a defunct biopharmaceutical company, received substantial government support to develop a COVID-19 vaccine that it never delivered.

All-Time Waste Award Goes To ...

This next waste might just win the all-time waste award:

The Canadian government managers [paid nearly \\$700,000 to consultants to get advice on how to save money on consultants](#), according to an Inquiry of Ministry tabled in the House of Commons and first reported by Blacklock's Reporter.

According to documents tabled in the House of Commons, KPMG, one of the management companies contracted by federal managers, assisted Natural Resources Canada "to develop recommendations that could be considered as options to ensure Canadians' tax dollars are being used efficiently and being invested in the priorities that matter most to them."

The federal government disclosed in the Inquiry document that the Department of Natural Resources hired KPMG to "develop recommendations" to ensure Canadians' tax dollars "are being used efficiently and being invested in the priorities that matter most to them." The 'them' appears to refer to the average Canadian, but it this is double-speak. The 'them' really refers to the politicians and bureaucrats they are in cahoots with.

It appears that the \$669,650 to KPMG consultants is over and above the \$700,000 paid to 'consultants'. In addition, the Treasury Board knew of several instances where consultants were hired to check the work of other consultants.

Here's free advice: stop hiring KPMG for starters and start hiring ethical and knowledgeable bureaucrats who can do their own research. Another idea – call in law enforcement and prosecute, with prison time as a deterrent.

University of Ottawa Prof. David Zussman notes that contractors are now being tasked with policy development work at many government departments, something that used to be up to the core public service.

Remember that this 'consultant' scheme is operating at not only the federal level, but with impunity and unaccountability at the provincial and municipal levels.

Some of the most well-known names in the DEI industry were also employed by DND. Diversity and equity contracts signed by National Defence included a \$22,600 guest speaker payout signed off on January 16, 2024, for Saint Mary's University Social Justice professor Dr. Rachel Zellars. Purpose: for a Black History Month celebration.

A report on the investigation into the hiring of consultants in the Joly's foreign affairs department disclosed April 25, 2024, [uncovered routine irregularities at a rate of 26% between 2018 and 2023](#).

Maurice Chenier is the chief executive officer of the Information Technology Services Branch at Public Works Canada. About a third of the staff in his department are consultants.

"They're talking about the need to reduce the public service, to be efficient in the current economic climate, at the same time costs are going through the roof on these kinds of things like contracting out. It's a philosophical change ... just like the corporate agenda."

Just as they did when they claimed that COVID-19 was a new disease when in fact they had simply renamed the seasonal flu, the government is **'reducing' the size of government by renaming public servants 'consultants'.**

The president of a union representing thousands of professionals is slamming the federal government over its increasing use of consultants, saying the practice could lead to weaker and far more expensive services for Canadians.

Under the section in the Public Accounts of Canada report, "Losses of public money due to an offence, illegal act or accident," the Public Health Agency of Canada (PHAC) has an "[Unfulfilled contract by a vendor](#)" worth \$150,000,000.

Of course, PHAC has refused to disclose who the vendor is. And yes, you can safely bet the contractor is an insider. Fifteen million dollars [unaccounted for and purportedly connected to a 'vaccine deal'](#) can grease many a pocket. It is noteworthy that PHAC is not a Canadian agency despite its name – it is a department and fully controlled by the World Health Organization, run by Dr. Theresa Tam who masquerades as the Chief Medical Health Officer of Canada, but who actually was exposed having a secret contract with the WHO.

There should be absolutely nothing confidential in the dealings between 'public SERVANTS' and the people who foot the bill. But in this corporate government, everything the corporation masquerading as government does is secret.

It's not a secret that they are openly stealing our money, resources and property. They don't care that we know.

Absolute Incompetence

The Canadian Mortgage and Housing Commission (CMHC), a Crown corporation, said that it must "do better" to improve the affordable housing situation after data showed one expensive initiative resulted in [just 12 homes in eight years](#). (Story is behind an EpochTimes paywall.)

The program involving Crown land began in 2015, purported to build 672 homes in seven communities across the country, including Edmonton, Calgary, Sudbury, Ottawa, Sherbrooke, Halifax, and St. John's.

However, just 12 homes had been completed, and they were all in the community of Sherbrooke, Quebec. What happened to the tax dollars earmarked to this failure? Who knows, but you can guess that some pockets have been well greased.

How many executives at the Bank of Canada do you think are needed to drive the Canadian economy into the ground?

Eighty-two (82) according to The Canadian Taxpayers Federation that obtained records through an access-to-information filing which revealed that of the 82 executives working for the Bank of Canada, all but two received bonuses for either "at-risk pay" or "performance pay."

That's 98% of their staff got big rewards for their worst achievements in 4 years. And that's only for 2022.

Since 2015 (the year the Liberals got into power), [these useless bureaucrats, got \\$20,960,416 in bonuses](#) – that's on top of their regular salaries, benefits packages and other goodies.

They've done well for Justin Trudeau – our economy may never recover. It's clear the bonuses were for their participation in destroying Canada.

In documents obtained by the Canadian Taxpayers Federation (CTF), 89% of federal executives received yearly bonuses during the pandemic.

That's up from the \$171 million in bonuses handed out in 2020, which had seen federal departments fail even more drastically by only meeting 48% of their performance metrics.

In addition, despite meeting performance goals less than 60% of the time, [federal public servants received just under \\$200 million in bonuses](#) in 2022, mostly to public administration executives.

That reward for being incompetent, ineffective and inefficient brings total bonuses handed to federal workers during the COVID-19 pandemic to over half a billion dollars, paid out between the 2019–20 and 2021–22 fiscal years.

And that, my friends, is how to keep you foot soldiers loyal.

Canadian Taxpayer Federation Federal Director Franco Terrazzano provided these [statistics for 2022](#) (archived [copy](#)):

"Bank of Canada bureaucrats got \$20 million in bonuses in 2022 while the Crown corporation hiked interest rates seven times and inflation reached a 40-year high.

The average bonus among staff was \$11,200, with 80 per cent of the workforce receiving one, according to internal government records obtained by the CTF through a series of access-to-information requests.

The Bank of Canada also dished out \$6.5 million in raises in 2022.

Since the onset of the COVID-19 pandemic, the Bank of Canada rubberstamped nearly \$72 million in bonuses and pay raises for staff.

Not a single Bank of Canada employee had their pay cut in 2020, 2021 or 2022.

In December 2015, a total of 487 Bank of Canada staff took home more than \$100,000 annually, representing 30 per cent of its workforce.

In December 2022, 1,095 staff took home more than \$100,000 annually, representing 49 per cent of the workforce.

"Bonuses are for people who do a good job, not people who fail at their one and only job, most organizations don't shower employees with bonuses when they have their worst year in four decades."

And this is why the executives were executing Canadians literally and figuratively (elderly and children) since 2020 – they were paid to enforce absurdities and atrocities. Always follow the money.

Now for a clever way to launder money -- pay rewards to political supporters by overpaying them: According to a Global News Report October 27, 2012, Canada's Auditor-General found that the government's Phoenix System overpaid 100,000 bureaucrats by ½ billion dollars!

Like the ArriveCan app, the Phoenix payment system never worked properly but cost billions of dollars and no one is accountable, because they all got a piece of the pie.

I'm starting to think governance by pedophiles and sexual predators/deviants covertly controlled by Intelligence agency blackmail rings isn't the ideal political structure.

In 2014, an expert fraud investigator unveiled the "Four Horsemen", [Frauds of the Government of Ontario](#) and the ministers responsible refused to address the widespread fraud altogether, apparently a 'discretion' that corporate provincial government ministers can engage in with impunity.

In a press conference held at the Sheraton Centre Toronto on June 3, 2014, Gerry Jutsun, President of FSI Fraud Security Investigations, unveiled four seminal and profound frauds, which involve elements of the Ontario government and are widespread and damaging to the public trust. They had been going on for years already.

Referring to these frauds as "The Four Horsemen", Jutsun provided media outlets in attendance with a **summary of the four most prevalent government frauds: malfeasance, breach and intentional interference with respect to daycare licensing practices; seniors being defrauded of their life savings by investment firms; fictitious and potentially deceased plaintiffs being entered into court to affect judgements against defrauded parties; and mothers and fathers through family law, being thrown into prison without being charged with a crime and with no due process of law.**

Premier Doug Ford's point man at Metrolinx, Phil Verster, the CEO of this Crown Corporation, is getting paid eight times what he was paid four years ago. Are you?

While families deal with decades-high inflation, Ford governmental bigwigs are handed massive wage increases like candy and that's not including the 'bonuses'.

When Verster was first hired in 2017, the Wynne government gave him a starting salary of \$104,000 – 4 years later the Ford government is paying

him a salary of \$851,000.

That's a 718% increase in a period of just four years! Apparently, it costs mightily to hire someone who can cause an unmitigated transportation disaster.

The new Ontario line being built in Toronto is already \$8 billion over budget thanks to Verster. The Eglinton Crosstown project in Toronto is three years behind schedule.

And the cost of building a railway underpass to better connect Burlington and Oakville is coming in at three times the cost of what Metrolinx originally promised.

Verster is just one example of a larger problem: government is spending an insane amount of your tax dollars paying provincial bureaucrat salaries that look more like NHL contracts than typical private sector paystubs.

Other examples include the Landlord Tenant Board and Tribunal, the Land Tribunal, ServiceOntario and ServiceCanada and the entire medical system –**where the greater the salaries, the worse the performance of the directors and CEOs of these corporations.**

According to this October 21, 2022 [National Post report](#) (archived [here](#)), GC Strategies billed the Canadian government \$9 million over two years, with most of that money being paid out to software engineers and others who actually built components of ArriveCan, the company's managing partner, Kristian Firth told the government operations and estimates committee.

Vacations Disguised as Conferences

Conferences attended by bureaucrats and politicians are typically opportunities for vacations on taxpayer dollars. For example: The Trudeau Liberals spent at least \$ [1.5 million on hotel rooms for a UN biodiversity conference in 2023+](#), that could have easily been held on Zoom.

These costs were associated with hosting just one of the many United Nations Biodiversity and other conferences in Montreal, Vancouver, Ottawa and in foreign countries.

"The total amount paid for hotel rooms at Intercontinental Montreal (\$286,060.46\$) and Le Westin Montreal (\$1,252,991.73) was \$1,539,052.19."
