



CRA COLLECTS TAXES FOR FOREIGN STATE

Canadian and American (1871 est. Crown Corporation) property & personal Income Taxes are unlawfully collected for the Crown (the Pope).

The United Nations is the administrator of the World Government and runs a coalition with the Chinese Communist Party, the Islamic State and the World Economic Forum (WEF).

All domestic courts are being replaced by UN Tribunals that impose UN Administrative Law, not domestic Common Law, thereby turning even fundamental human rights and freedoms into privileges through Tribunal 'decisions' that are given deference by the remaining courts. Regular courts are required to see Tribunals as experts in the fields they adjudicate. One of those Tribunals is the Tax Court which is not a regular court, but a corporate court.
